 - a. "The word of God purely preached and heard" (4, 1, 10; 4, 1, 5)
 - b. "Sacraments administered according to Christ's institution" (4, 1, 10; 4, 17, 43-44)
 - c. Discipline is not a third mark but indispensable ("like the sinews..." 4, 12, 1)
 - 1) Aims of discipline (4, 12, 5)
 - a) Preserves the honor of God
 - b) Protects the good from the wicked
 - c) Leads the offender to repentance (4, 12, 8; 4, 12, 11; Sermon on Galatians 6:1, 2)

 - 2. As long as the church retains its marks, we must not reject it "even if it otherwise swarms with many faults" (4, 1, 12)
 - a. There may be some "fault" in doctrine or sacrament (4, 1, 12)
 - b. "Imperfections of life" (4, 1, 13; cf. 4, 1, 14; 4, 1, 18; 4, 1, 20; 4, 1, 13; *Commentary* on 1 Corinthians 1:2)
 - 3. "Comparison of the false and the true church"
 - a. Two levels of false churches
 - 1) Lacks "lawful form" marks missing (4, 2, 1); Christ absent (4, 2, 12)
 - 2) Calvin separated from the Roman Catholic church ("they have expelled us" [4, 2, 6]; *Commentary* on Zechariah 8:23)
 - 3) Requirements of the true church (4, 1-4) followed by arguments that the Roman Catholic church is not a true church (4, 5-11)
 - a) "The papacy itself is directly contrary to church order" (4, 12, 26)
 - b) But "traces of the church" remain (4, 2, 11)
 - (1) "A remnant of his people" (4, 2, 12)
 - (2) Baptism and "other vestiges" (4, 2, 11)

III. Church Order

A. Scripture reveals an order of permanent validity (4, 4, 1)

- B. With considerable freedom (4, 10, 30-32; *Commentary* on 1 Corinthians 14:40)
 - 1. Love should be "our guide" (4, 10, 30)
 - 2. Importance of decorum, dignity, propriety (4, 10, 30; *Commentary* on 1 Corinthians 11:2 and 11:4; Letter to the English exiles at Wesel [March 13, 1554], Letter to King Sigismund [Dec. 5, 1554], Letter concerning the Anglican Prayer Book [Jan.13, 1554])
 - 3. Importance of peace in the church (Letter to Bullinger [March 1551])
